#### NAFA Annual General Meeting in British Columbia

Continuing our practice of trying to hold the Annual General Meeting in different areas of North America, our next annual meeting will be held in Abbottsford, BC at the Abbottsford Inn, 5 December The meeting will be held following the Dogwood Pacesetters tournament in Matsqui. All delegates are welcome and encouraged to attend. Ballots for the three Board of Directors positions as well as that of the Executive Director will be opened and counted. The results of the election will be announced at the meeting. Other agenda items will include reports from Chairman Alan Weiner and Executive Director Steve McAvoy. Kaylor will be presenting the financial report. Time will also be allotted for questions and/or discussions from the floor. Delegates, in attendance, may present motions for rule changes at the annual meeting provided the motion is specific and is presented in writing prior to the meeting (Section 8.1). The Board of Directors will hold their regular board meeting on the 4<sup>th</sup> of Dec. (Fri.) and will be available (although we've all been told that we will be working very hard) at the tournament for informal discussions.

By now, all ballots have been mailed out along with the brief resume of each candidate. Returning ballots may be hand-delivered at the annual meeting and submitted before the meeting starts. Ballots may also be returned by mail, and will be accepted provided they arrive on or before the 3rd of December '98. Returning ballots should be mailed to the NAFA Nominating Committee c/o Jim Sova, 1799 Highway 13, Marion, IA 52320 or Canadian delegates may return their ballots to the NAFA Nominating Committee c/o Val Scott, 2109 Melrick Pl. RR #3, Sooke, BC, V0N 1N5. It is very important to write "NAFA Nominating Committee" on the top of each address so that ballots may be brought unopened to the annual meeting.

#### Effective 1 October 1998

Limited tournaments sanctioned after 1 Oct '98 shall not accept entries until 30 days before the closing date. The NAFA News will put the "opening date" on the tournament schedule list.

#### Effective 1 October 1998

There will be a \$25 US fee to register a new team with NAFA. This fee will include a rulebook.

He won't take credit for this agreement himself so I will thank him for all his efforts. This will be the biggest advance for all of flyball since the introduction of the Electronic Judging System. Thank you Alan and everyone who volunteered their time and efforts for NAFA in this endeavor.

Currently I am working with NAFA's attorneys and several Board members to refine and update NAFA's structure. When all the final details are complete they will be announced.

Val Culpin is currently developing a Judges Video, which will be used by NAFA to help train new judges and regional directors. Some of the other projects currently in the works at NAFA is the development of an information package for incoming Board members, development of an information update for the NAFA web-page to inform people of projects the board is currently working on. Also on the agenda is to upgrade the NAFA software to streamline the stats job. Dale Smith hopes to have this in place very shortly. We have also drafted a form letter for board members to return when they receive a request or a letter.

NAFA ballots are being mailed to the delegates. Please make sure you exercise your rights, mark your ballots and return to the address listed on your ballot. NAFA is currently enjoying tremendous growth and we can attribute this to the fact that flyball is a fun, exciting, fast-paced sport for everyone.

# How to Obtain a Height Card from NAFA

Send \$5.00 US along with the dog's name, CRN, handler's name & address to Sue Rogers, 40225 Regency Drive, Sterling Heights, MI 48313.

The following is the Height Card Policy (Section 6.6.g.ii):

Height cards are to be optional. Applications for height cards, at the cost of \$5.00 US funds each, must be applied for through NAFA. application will be embossed with the seal corporate and numbered. Applications must be presented to the measuring judge before the dog is All dogs will need 3 measured. matching measurements from 3 different approved NAFA judges. At least one of the 3 judges must be a NAFA designated Supervising Head Judge. All dogs must be 18 months of age before their 1st measurement. When a final height card is issued and recorded, it must be presented at each tournament entered and posted on the jump height sheet (NAFA Form C.9). Final jump height cards can not be contested. Final height cards issued by NAFA will be wallet size laminated cards and will be good for the life of the dog. Handlers, who forget their height cards at any given tournament, may have their jump heights contested.

\*\*Please note that all judges have been informed they are not to measure, for height cards, any dogs owned by themselves or by any of their teammates.
