NAFA EJS Update

NAFA currently owns three Electronic Judging Systems (EJS) that are used at NAFA sanctioned tournaments. Two of these systems are used predominantly in the United States and one is used predominantly in Canada. We attempt minimize the to distance we ship systems and the number of times they need to cross the border. NAFA also still owns one of the old solidstate EJS's which is used only in dire circumstances. It is heavy and cumbersome to ship and the timers no longer operate. Once more of the newer systems are available. this system will likely be rebuilt into a newer system.

NAFA has recently ordered two additional EJS's that should become available for use sometime early this summer. One will be used predominantly in Canada and one in the US. Both are basically the same as our current EJS's.

There is also work underway to develop the next generation of EJS for NAFA. The goals of these EJS are centered on making the sport more exciting for spectators. This will include displays of the times dogs run as well as other enhancements being considered. NAFA Club Ownership Review

Over the past several years, NAFA has dealt with a number of questions regarding club ownership. From a NAFA perspective, a NAFA registered club name (and number) is "owned" by the captain (the person registering the club). The only way this ownership can change is if the currently registered "owner" informs NAFA that they are transferring ownership to a new captain. This notification MUST come from the existing owner. A club owner may also be a corporation (for those clubs that are legally incorporated).

NAFA will not get involved in internal team disputes or issues. The registered club captain has complete control regarding issues between the club and NAFA. This includes – what dogs are in a club, club delegate assignments, disbanding a club and any other NAFA communication regarding the registered club (except as distributed to assigned delegates).

Delegates earned by a club are the sole responsibility of the captain and may be distributed to other persons at their discretion. A club captain may reassign delegates at any time by notifying NAFA. The change will take effect when it is received by NAFA.

Please ensure that your club members are aware of these policies. Hopefully this information will avoid future misunderstandings.

<u>Delegate List</u> <u>Availability to</u> <u>Candidates</u>

In the past, candidates have requested a list of NAFA delegates for campaign purposes. As our organization continues to grow, it is nearly impossible for all candidates to be known by all of the voters the delegates. The Board agrees that it is desirable to give candidates access the to delegates, but felt that the delegates should be informed that their names and addresses would be distributed. In 1999 we, currently, intend to make a list of the NAFA delegates available to candidates on request solely for campaign purposes. If you are a delegate and this is a concern you may wish to have your team captain modify your delegate information or select another delegate. It is currently not our intention to have "unlisted" delegates. Candidates deserve access to those who will be voting on them.
